#### Criminal Record check and disclosure and consent

Integrity and honesty are essential requirements for accreditation as a player agent.

Your criminal record information will be considered in assessing your application. Your application may be refused if:

- It is determined your criminal record affects your ability to perform the requirements of a player agent; or
- You provide false or misleading information about your criminal record.

If you choose not to provide criminal record information or choose not to consent to a criminal record check, your application will not be considered by AFL Players' Association.
